VISITING JUDGES Fact Sheet

The Fifth Administrative Judicial Region ⁽¹⁾

The State of Texas is divided into nine administrative judicial regions. The office of the Fifth Administrative Judicial Region (5th AJR) is located in Brownsville, TX and currently serves eleven counties. The counties currently being served are Brooks, Cameron, Duval, *Hidalgo*, Jim Hogg, Jim Wells, Kennedy, Kleberg, Nueces, Starr, & Willacy.

(1) GC Sec. 74.042 (a) & (f)

Duties of the Presiding Judge of the 5th AJR ⁽²⁾

The Hon. J. Rolando Olvera is the current Presiding Judge of the 5th AJR. The duties of the Presiding Judge of the 5th AJR and all AJRs include:

- Promulgating and implementing regional rules of administration
- Recommending changes to the Supreme Court for the improvement of judicial administration
- Assign visiting judges to hold court when necessary to dispose of accumulated
- Advising local judges on judicial management
- Act as local administrative judge in their absence

(2) GC Sec. 74.046 (1-8); GC Sec. 74.052 (a)

Qualifications to be a Visiting Judge ⁽³⁾

The following judges may be assigned by the Presiding Judge of the administrative judicial region in which the assigned judge resides:

- An active district, constitutional county, or statutory county court judge in this state
- A senior judge who has consented to be subject to assignment
- A former district, or appellate judge, retired or former statutory probate judge,
- A former district, or appellate judge, retired or former statutory probate judge, before retirement was justice or judge of the supreme court, the court of criminal appeals, or a court of appeals
- An active judge or justice of the supreme court, the court of criminal appeals, or a court of appeals who has had trial court experience

*Note: A judge assigned by the Administrative Judge has all powers of the judge of the court to which he/she is assigned.

(3) GC Sec. 74.054 (1-5)

Visiting Judge Compensation ⁽⁴⁾

The salary of a retired judge or justice while assigned shall be paid out of money appropriated from the general revenue fund for that purpose in an amount equal to the compensation received from state and county sources of the judge of the court to which he is assigned. The salary of a retired judge or justice while assigned shall be determined pro rata for the period of time that the judge or justice actually sits as the assigned judge.

*Note: Assigned Visiting Judges submit the "Visiting Judge's Salary Claim" form to the State Comptroller's office, upon approval of the Presiding Judge listing every day or half days



Unemployment compensation is usually paid on the basis of wages earned in the "base period".

Base Period


The "base period" is defined as the first 4 quarters of the last 5 completed calendar quarters of wages. The base period determines the wages that will be used to compute the claimant's benefit amounts and which employers will have potential chargeback or reimbursement liability for any benefits paid to the claimant

Base Period Employer

A "base period employer" is one the employee worked for in that period, who's account would be charged by the unemployment office through unemployment taxes.

Example:

- If the claim is filed in April, May or June of current year, the base period is January through December of the last year.
- If the claim is filed in July, August, or September of the current year, the base period is April through December of the previous year and January through March of the last year.
- If the claim is filed in October, November, or December of the current year, the base period is July through December of the last year and January through June of the current year.
