REGARDING CASE MANAGEMENT ORDER NO. 2



MDL CASE MANAGEMENT ORDER NO. 2

In all cases, the parties are only permitted to serve the Hidalgo County Hail MDL Master Discovery and Rule 194 Requests for Disclosures.

Any other written discovery is hereby stricken.

A party may seek additional written discovery from the Discovery Master by filing a motion for leave and providing notice to Plaintiffs' Liaison Counsel and Defendants' Liaison Counsel.

A party may request another party to answer discovery by serving a letter identifying the appropriate Master Discovery requests the opposing party shall answer. No party shall serve a letter requesting discovery be answered until after the Mediator's Statement (Exhibit D attached to CMO No. 1) is filed with the Court declaring an impasse or the date notice is received by a party that the opposing party desires to unilaterally end the abatement period applicable to a particular case. Responses and objections shall be due no later than 30 days after the date the letter is served.

The parties may modify these days in accordance with T.R.C.P Rule 11.
